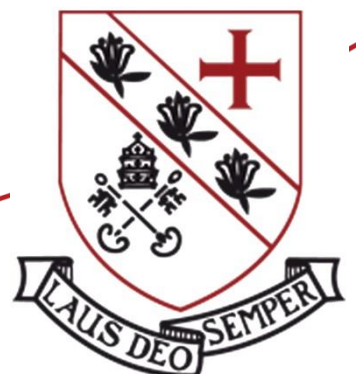

### **Job Purpose**

To provide cover for evening and weekend users of the College facilities

### **Main Tasks**

- Site management responsibility, including Fire, Access Control, Cleaning for all lettings and people onsite using the premises.
- Monitor booking system to ensure a full understanding of each individual letting's requirements.
- Daily feedback to the other Facilities Co-ordinator, to ensure smooth daily transition
- Communication with finance and lettings admin on daily attendance, monies
- Porterage of goods in items.
- Health and Safety management of Office and classroom space.
- Undertake other relevant duties as directed

To undertake other duties within his/her competence or otherwise appropriate to the grading of the post as required.

To work positively and constructively with the line manager to identify strengths and agree an action plan in relation to development needs, to set these out in a personal development plan which will be reviewed regularly with the line manager
